1. Acknowledgment and Agreement

_By enrolling in or participating in any training session, class, evaluation, or related service provided by LSK9 Advanced, you ("Client") agree to the following Terms of Service. These terms are legally binding and apply to all participants, handlers, and dogs involved.

2. Assumption of Risk and Release of Liability

_The Client understands that dog training involves inherent risks, including but not limited to injury or illness to persons, dogs, or property.

_The Client assumes full responsibility for any and all risks, injuries, damages, or losses that may occur during or after training, whether on or off the premises.

_The Client agrees that LSK9 Advanced, its owners, trainers, employees, agents, and affiliates shall not be held liable for any injury, loss, illness, or damage to any person, dog, or property arising from participation in training services.

_The Client agrees to hold harmless and indemnify LSK9 Advanced against all claims, damages, or expenses (including attorney fees) arising from their dog's behavior or participation.

3. Health and Safety Requirements

_All dogs must be up-to-date on vaccinations as required by state or local law.

_Dogs showing signs of contagious illness, parasites, or injury may be turned away from class or private sessions until cleared by a veterinarian.

_The Client certifies that their dog has no history of aggression that has not been disclosed to the trainer.

_The trainer reserves the right to remove any dog or handler from a session if safety concerns arise.

4. No Guarantee of Results (Classes & 1v1 Lessons)

_The Client understands and agrees that dog training is as much about training the handler as it is the dog.

_LSK9 Advanced will make every reasonable effort to help the Client achieve training goals; however, no specific results are guaranteed.

_The success of training depends on the Client's consistency, timing, follow-through, and

continued practice outside of sessions.

5. Adventure Pup Promise: Exclusive Care With Us! (**APP ONLY**)

At LSK9, your dog's safety, happiness, and well-being are our top priorities. By enrolling your dog in our Adventure Pup Program, you agree to the following exclusive care commitment:

_Sole Care Provider: Following the enrollment, LSK9 will be the exclusive doggie day care provider and supervision for your dog. Our Adventure pups may not be going to other doggie daycares without termination with our program.

_Health & Safety Standards: All dogs must meet our health, vaccination, and behavioral requirements (or on a training plan) to ensure a safe and enjoyable experience for every pup in our care. We reserve the right to refuse or discontinue services if a dog poses a risk to themselves, other dogs, or staff.

_Trust & Consistency: Our exclusive care model allows us to maintain consistent routines, training methods, and safety protocols. This consistency is essential to your dog's success, comfort, and overall experience.

_Emergency Care Authorization: In the event of an emergency, LSK9 is authorized to seek veterinary care as deemed necessary. Every effort will be made to contact the owner, but immediate action may be taken in the dog's best interest.

_Policy Compliance: Failure to comply with this exclusive care agreement may result in suspension or termination of services without refund.

6. Payment and Refund Policy

_Payment is due in full at the time of booking or at the first session, unless otherwise agreed in writing.

_All sales are final. No refunds will be issued for missed sessions, cancellations, or perceived lack of results.

_Credits or rescheduling options may be offered solely at the discretion of LSK9 Advanced.

7. Cancellations and Attendance

_A minimum of 24 hours' notice is required for cancellations or rescheduling of private lessons.

_Failure to provide notice may result in forfeiture of that session.

_Group classes begin promptly; late arrivals may not be admitted once class has started to ensure safety and structure.

8. Media Release

_The Client grants permission for LSK9 Advanced to photograph or record their dog during training for educational or promotional use.

_No identifying information about the Client will be shared without consent.

_If the Client does not wish for photos or videos to be used, they must notify LSK9 Advanced in writing before training begins.
